PRODUCT SPECIFICATION

Description: A clear colourless liquid, free from matter in suspension. Contains predominantly ethanol and water. Distilled wholly from fermented sugars of Australian wine grape origin using a continuous distillation process to a strength of 96.0 % or greater ethanol by volume at 20°C.

Aroma: Neutral ethanol characters normally associated with grape alcohol distilled at high strength.
